BUSINESS SURVEY

At the recent Headquarters 1st mini-reunion the board members requested everyone attending to fill out a multiple-choice survey. 26 people responded. Here are the results.

DUES: members were asked to indicate their preference on five related questions:

- 1. Veterans or their surviving widows should be exempt from paying dues
 - a. Vote Tally: (17 Agreed, 8 Disagreed, 1 Blank)
 - b. Result: Veterans and/or their widows are exempted from paying dues.
- 2. Dues should be assessed per household address, not per individual
 - a. Vote Tally: (18 Agreed, 5 Disagreed, 3 Blank)
 - b. Result: Association dues will be assessed on a per household basis.
- 3. All Association members should pay \$10 dues per year
 - a. Vote Tally: (18 Agreed, 5 Disagreed, 3 Blank)
 - b. Result: All nonexempt member households will pay \$10 dues per year
- 4. There should be no dues paid, the association should depend on voluntary donations
 - a. Vote Tally: (4 Agreed, 18 Disagreed, 4 Blank)
 - b. Result: The association will not run on donations alone.
- 5. Legacy honorary members should continue to be exempt from dues.
 - a. Vote Tally: (17 Agreed, 5 Disagreed, 4 Blank)
 - b. Result: Legacy honorary members

will be exempted from annual dues

Diablo Newsletter Distribution:

- 1. Newsletter should be sent to active members only
 - a. Vote Tally: (9 Agreed, 14 Disagreed, 3 Blank)
- 2. Newsletter should be sent to all veterans, family and friends regardless of membership status.
 - a. Vote Tally: (21 Agreed, 5 Disagreed, None Blank)
- 3. Result of above two votes: Newsletter will be sent to all veterans, family and friends

2007 Reunion Venue Preferences:

- 1. Southeastern U.S. (11 Agreed, 6 Disagreed, 9 Blank)
- 2. Northeastern U. S. (5 Agreed, 8 Disagreed, 13 Blank)
- 3. Southwestern U.S. (14 Agreed, 3 Disagreed, 9 Blank)
- North central U.S. (8 Agreed, 5 Disagreed, 13 Blank)
 - a. Result: Emphasis will be given to reunion sites in Southeastern and Southwestern U.S.

Consideration of School Calendars When Scheduling Reunions:

- 1. July (12 Agreed, 6 Disagreed, 8 Blank)
- 1. August (13 Agreed, 5 Disagreed, 8 Blank)
- 2. October (5 Agreed, 10 Disagreed, 11 Blank)
 - a. Result: The months of July and August will be given preference in scheduling future reunions.

Survey Lowdown:

Several items stand out in the survey. The first one being that dues are only going to be \$10 and there are no dues requested of veterans. This is going to mean we really need good, active sign-up by the "family and friends" types out there in order to keep funds in the bank account.

Second issue is related to the first – that all family/friends should continue

to receive the newsletter regardless of membership status. Our current mailing list is over 1450 people. Some of these may be duplicate addresses and will be combined. This results in us having to wonder how we pay for the mailing but we will figure it out somehow.

The latter two items have to do with future reunions. We WILL have a regimental reunion in 2007.

Newsletter Distribution

Since it has been decided that all Family and Friends shall receive the newsletter regardless of membership status, we need to be thinking of cutting distribution costs. Postage for each quarterly newsletter edition will be approximately \$550 unless costs can be held in check - and that doesn't include the cost of printing the items to be mailed.

Use of e-mail immediately comes to mind as a cost cutting mechanism. The newsletter can be attached in either Microsoft's Word or Adobe's PDF formats – or both.

As a consequence, an experimental mailing will be made to determine how up to date our e-mail address list is. If, by the time that you read this, you didn't get an experimental mailing, your e-mail address is one of those that are obsolete.

We suspect that many currently known e-mail addresses will fail and we will be forced to spend postage to reach those parties. Some copies, of course, will have to be posted to those who do not use e-mail.

Bill intends to read the book from cover to cover and find a suitable place amongst his law books. Meanwhile the mug sits on his desk where he says it is "quite a conversation piece."

New Fiscal Year Dawns

Based on our newly adopted By-Laws, the association's fiscal year will run from November 1^{st} to October 31^{st} – Happy New Year!

During our first business meeting in Orange Park, FL in October 2005 it was proposed that we collect an "Initiation Fee" of \$30 during calendar 2005.

The monies collected during the past fiscal year, coupled with some donations, were used to develop a reserve account. It is through the largess of those who contributed this "seed" money that we are able now to leap forward as a freestanding and self-sustaining organization.

We cannot, however, expect these funds alone to sustain us forever.

As a consequence, we agreed to collect \$10 annual membership dues on a "per household" basis.

SSgt Richard Howell

My dad was SSgt Richard R. Howell (Dick Howell). He was assigned to the Regimental HQ Co, 508th while the regiment went thru training in the states before deployment to Europe. Upon deployment he was assigned as a section sergeant to the 101st's naval gunfire support detachment and was attached to the 501st for the Normandy drop.

Apparently as the battle moved inland the airborne divisions decided they did not need naval gunfire detachments and they were all reassigned to the Pacific. My dad ended up in the 674 GFAB of the 11th Airborne in the Philippines.

In his scrapbook he had a lot of stuff from his time with the 508th and so I thought I would forward it to you.
