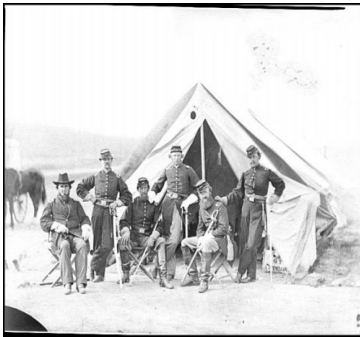

Chapter Social

The reason the newsletter was late was due to the uncertainties concerning the availability of McKellers Lodge for the Chapter Social on

Down Memory Lane

508th PIR — March - April 1944

On March 14 the 1st Battalion, 508th loaded into C-47s for a training drop and problem to keep their skills honed.

During the drop one C-47 threw a propeller for its right engine and began to lose altitude. The troopers quickly exited the aircraft while the pilot desperately tried to keep this aircraft above the jumpers in the air. Chute after chute was plucked from the air by wings and tail as the aircraft plunged earthward. Seven members of the 508th and four crew members were killed in this tragic accident.

On April 4 the long attachment of the 508th to the 82nd Airborne Division came to an end. The Regiment was placed under the direct control of the First Allied Airborne Army. Immediately the Regiment packed up and moved by truck to the railroad station at Laon. Once again boarding the 40-and-8s the troopers were moved across France, arriving the next day at Chartres, southwest of Paris. Here the Regimental CP was established and the Regiment went to nearby airfields, prepared to jump on forty-eight hours notice to liberate prisoner of war camps if the Germans resorted to atrocities.

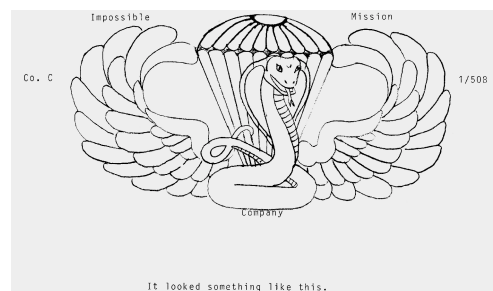
508th ARCT — April, 1954

On 8 April 1954 the Regimental Combat Team was reorganized at Fort Campbell, KY as a General Reserve Class 1 unit. The Regiment received additional troops and began intensive training.

Membership Letters

Robert H. Cooper (C/51-54) writes: Here is my \$100.00 lifetime membership fee.

The following is info regarding the Guinea Pig Platoon of 1951, of which I was one of the 50 so called "volunteers." (See Red Devil Digest Sep - Oct 2000).

Our daily routine was to arise at 3:30 or 4:00am, provide a urine and blood sample and receive a syringe of a milky liquid in the amount of the blood drawn. One of the Doctors told me the liquid was Sodium Salicylate (aspirin). During training hours the Doctors were always close by, asking questions and making notes. We would sometimes receive other types of injections during the day. Once we were given a shot in the shoulder and was told it was adrenalin - we almost immediately began to shake violently.

I do not know what this thing was all about, but I am certain it was not for the reasons given. At the time I had my suspicions, and even more so when after leaving the Army in 1954 I found my blood type had changed from type B Neg. to B Pos.

Doctors here are at a loss to explain how this happened?

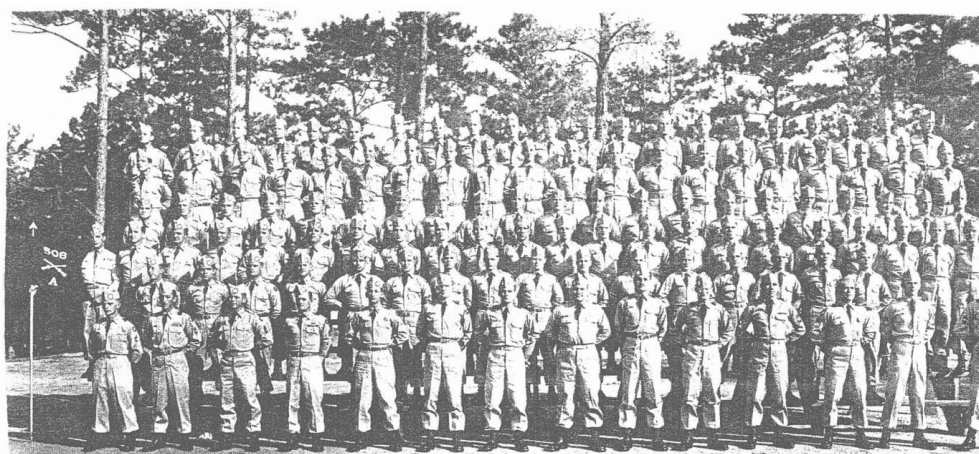

The picture to the left will bring back memories to the Red Devils stationed at Fort Campbell, Ky prior to the ARCT's departure to Japan in July, 1955. The 11th Abn Div banner was located to the right of the road leading into the Fort from the main gate off of US 41. One dark evening unidentified Red Devils superimposed the 508th ARCT shoulder patch over the 11th Abn Div patch. In lieu of the AIRBORNE TAB, the unknown Red Devils had printed the words "Ain't we Devils."
