#### **ALL AMERICAN WEEK 2008**

My trusty navigator, Bonnie and I departed Columbus, GA on Monday. We took state and federal roads, most near interstate quality, four lanes and very little traffic. We arrived in Fayetteville in mid afternoon on Tuesday. I had made the room reservation at the Holiday Inn Bordeaux in January which helped my room assignment. My room was on the third floor of the main building. Roomy and clean and with a fridge and computer desk with internet hookup. All the doors and elevators worked well. Our All American Week registration was fast and painless. The two female soldiers at the registration room were courteous and pleasant and very helpful. We visited Fort Bragg around 4:30 and ate at a nearby mall. We stopped in the hotel grill and bar called Wiley's looking for some after dinner coffee. The bartender "Michael", made us two very fine Nutty Irishmen The place was busy and very coffee royals. pleasant. Wednesday started out as a beautiful day, bright and sunny and around 65 degrees. Free coffee with all the fixings was available in the hotel lobby. Breakfast at the K&W Cafeteria was as always, very good. The first bus left for the Airborne and Special Ops Museum at 11:00 AM. I had not visited this museum in several years and several additions and improvements have been made. A very large steel piece of art dedicated to the victims of 9/11 stands near the museum. Some steel from the mangled twin towers was used in the artwork. A few hundred U.S. flags stood at attention next to the art on six foot poles much like a military unit paying respect to its lost members. We caught a bus to our hotel for a short siesta prior to the picnic at McKellarslodge. We caught the bus to McKellars at 3:30 and were among the first 100 or so to arrive. The chow line was pretty short...

It was help yourself to beef ribs, barbeque chicken, hamburgers, hot dogs, rolls, potato salad, cole slaw, pie and cake. The drink selections were various iced down soft drinks, draft Budweiser or Killians Red. Hard booze mixed drinks were available. The cost was absorbed by the registration fee. A DJ and older type music were provided. Good food, good music and good people made for a good time. We caught a return bus around 7:30 PM. Thursday morning called for a 6:30 wake up because the last bus would leave at 8:00 AM. We arrived at Pike Field for the parade around 8:30 AM. We heard that the President would attend, so we were not surprised that his Secret Service had taken special security precautions. A portable fence was installed in front of the bleachers screening the lower seats from the parade field. Temporary fences divided the left and right bleachers from the center. A fence behind the bleachers extended the full width of the viewing area. At 9:00 AM the gates were closed and everyone was confined to the area they were located in. All spectators were corralled and could not leave prior to the ceremonies finishing, except the 15000+ paratroopers on the parade field and the old timers who would pass in review first. This method resulted in most old timers who marched not being able to sit with their families. It did not matter, all 5000 or so spectators were thrilled that President Bush was at Fort Bragg to honor the 82<sup>nd</sup> Paratroopers. When President Bush trooped the line, he walked rather than rode. When the official party departed, the people in attendance filed through a four foot gate in the fence to rejoin their families. All movement was controlled causing planned activities to run an hour or two behind schedule. Lunch with our Paratroopers in the troop area did not happen. We caught buses to the... ...82<sup>nd</sup> Museum for a touching ceremony. The 82<sup>nd</sup> Global War on Terrorism monument that our Chapter had donated to was dedicated. All wars where 82<sup>nd</sup> paratroopers died were recognized by veterans who fought in those wars. President Bush read from the book of Isaiah. Several dozen and perhaps hundreds of Gold Star Families of the GWOT KIA's were escorted to the monument one row at a time. The names of the KIA were announced over the PA system while the 82<sup>nd</sup> Soldiers Chorus sang appropriate songs like Amazing Grace in the background. Paper and pencils were made available so the names of the fallen could be etched or traced from the engraved names on the monument.

The buses then returned us to our hotel with plenty of time for a hot shower. The evening banquet was very good. The Soldier and NCO of the year were introduced and received numerous gifts for their accomplishment. SFC Joshua Carswell, an infantryman was from H&H Co. 1-325. SPC Russell Danley, Jr., an infantryman was from H&H Co, 1-505. Both men were very impressive paratroopers. morning we old vets and our families had the option of eating breakfast in the troop dining facilities. Buses carried us to the mess halls, then to Sicily Drop Zone. Static equipment displays were set up much like a fair grounds. We could chat with the troopers manning the Hundreds or perhaps thousands of displays. spectators sat in the bleachers for the Airborne demonstrations. A public address system blared

out what would happen during the Joint Training Exercise and we watched it happen. Heavy drop aircraft dropped howitzers. Several plane loads of paratroopers then hit the silk. Attack helicopters swarmed in on the objective area and used suppressive fires. The Airborne Infantry units then used fire and maneuver techniques to attack and assault the objective. demonstration went like clockwork. The People attending were heading for buses back to the hotel by noon. We caught a bus to Fayetteville Clubhouse at 1:30. The ribs, bbq chicken, cole slaw, buns, hot dogs and hamburgers were tasty and plentiful. We drank the free beer and did some old timer dancing to the tunes provided by the lady disk jockey. The Fayetteville Chapter and their great Clubhouse with the outside picnic area does a great job of supporting all aspects of the 82<sup>nd</sup> Airborne Division, our association, All American Week and the 82<sup>nd</sup> Museum. Chapter Chairman Frank Seif was unable to attend All American Week and will not attend the convention in St. Louis, so I was designated as our Chapter Delegate to AAW and the Convention. Our Chapter paid my Delegate / Registration fee of \$82.00 for the convention. A delegates meeting was scheduled for Saturday morning at 9:00 in the host hotel. It was my first time as a delegate and I arrived there early. #### 82ND ABN DIV ASSN CREDIT CARD

Several months ago one of our members voiced concern that the 82<sup>nd</sup> Association was providing personal information in exchange for the association credit card. I passed this concern on to National. The Association Executive Director sent me a two page answer. That explanation has been edited to fit into our newsletter and follows: In reply to your email, and our telephone conversation concerning a complaint from one of your members, regarding the sale of his name for marketing purposes. I wish to correct this misconception with respect to the "selling" of our membership list. The membership list has never been sold, nor will it ever be. I would also like to take this time to give you some background information regarding Bank of America and the Association's Credit Card. In 1985, the members requested that the National Office investigate the possibility of obtaining a credit card, reflecting the Association logo, parachute and glider wings, to be offered as a benefit to our membership as many other Associations have. Negotiations began and in 1988 a contract was signed with INTEGRATE to issue such card. The agreement stated that the Association was to release its membership listing (addresses only) to them for marketing purposes and a percentage of the cards' use (royalties) would then be provided to the Association to assist in defraying the cost of running the organization. The program was then brought to the attention of the Board of Directors, all Chapters and the membership via a General Membership Meeting, who in turn approved In 1992, the contract was terminated at the project. the request of INTEGRATE. Hence, due to the popularity of the credit card with our members, the National Office was once again advised to obtain another company to sponsor this program. In 1993, the three most reputable credit companies within the United States were contacted, and asked to submit a proposal outlining the design of the card and the amount of royalties the Association would receive. MBNA, being number two in the market and serving over 18 million customers, submitted the best proposal. Their long history of dealing with over 3700 other endorsing organizations was also a deciding factor. Therefore, the Board, Chapters and, once again, the General Membership approved the Consequently, as soon as the Association's Judge Advocate had thoroughly reviewed the proposed contract, made several necessary changes, and approved the final contract; the agreement was signed for a period of five (5) years with the option to continue on a yearly basis unless

either party decides to cancel. Be advised that one of the stipulations in our agreement with the MBNA (Bank of America) is that they have to sign a nondisclosure contract prior to receiving our mailing lists. Not to mention the applications are to refer only to our Association when mailed to the membership. Since we signed the contract on 30 June 1995, the Association has received over \$35,000.00 in rovalties. This money has helped to keep the Association financially solvent, helped to grant former troopers and their dependent children college scholarships, and has assisted in keeping our annual dues low when compared to any Airborne / Military Association. We do understand the frustration of some members about being contacted. We ask that you consider the Associations growth since this program's inception with over 31,000 members and an operating budget close to half million dollars. Therefore, we still feel it necessary to establish programs and contracts with companies who offer services to our members at no cost to the Association and yet allow royalties to come in and assist with the overall financial support. In regards to what other and to whom else this information has been "passed on to"; I assure you that our database is not available to the public. The only individuals who are eligible to receive any information are the Chapter Officers for the purpose of maintaining membership rosters and Bank of America, again with whom we have a signed non-disclosure agreement. Our members are proud to display the card, it is a recruiting tool and provides great benefit to the Association and our Educational Fund. However, if members want to opt out, they can inform National and their names will be added to the list with the other 4 members (out of 31,253) and their membership coded in our database to reflect that I have decision. ## MEMORIES OF A PARATROOPER By George Leese

I was not in the Heavy Weapons Platoon at the time, but I do remember them using the 106 spotting rifle to take out shooters on a balcony across the river. Another story I was told, the 106 took out a large boat or ship, depending on the teller, that was going up & down the river in Santo Domingo, taking pot shots at our guys who were at the still on the east side of the river. Another story, the 508 had a .50 caliber in an enfilade position on the east side of the river somewhere near the Naval Academy. As the story goes, because we had been ordered to only return fire with like caliber weapons when fired on, another Rule Of Engagement that convinced me to give up the Army as a career, our guys spotted a sniper who was using a balcony as a firing position to shoot at the Marines who were guarding evacuees at the Polo Grounds to the west of the city. We were prohibited from shooting at him, because he was not shooting at us, but in the opposite direction. To get around this ROE, the 50 crew did an adjusted fire on the side of the building to get the range, then adjusted precisely to the timbers supporting the balcony. One long burst from the 50 took out the supports and the sniper fell 3 stories. He never knew he had been targeted. Of course he had not been targeted, only the supports under his balcony, therefore, no rule violation. These stories were common, we paratroopers sometimes had to find a way to work around the rules of engagement. After the 2 - 508 took up positions along the dividing line between the rebels and the Dominican Army. things were always in a state of flux. One day we would be helping the Government forces, the next we would be neutral and actually arrange for food to be delivered to the rebels. After a while, things got so boring, there were special mission patrols made up of entirely Sergeants who volunteered just to do something. remember one of these non patrols that actually made the papers in the US. Somehow, the rebel's arms cache in a Dominican Army facility the rebels had occupied in southern Santo Domingo, mysteriously blew up. The rebels claimed that they had been attacked, but that

could not have been the case because we were officially neutral. Too long ago to remember much more, except that just prior to my ETS I was in charge of a guard detail that assisted in protecting the future President of the Dominican Republic. If I remember correctly, his name was Betancourt, not sure of the spelling. We were at the Dominican Republic's Military Academy at the time. George Leese, HQ Co 2/508

It has approximately 100 pages of text with dozens of photographs and maps. The common page header is "The 508th Parachute Infantry". There is no book cover, credits or author listed. The contents page names the five book parts that we have - Prelude To Combat, Normandy, Holland, The Ardennes and Occupation. Sixteen pages are missing, identified as Highlights of the Regimental History, Men Killed In Training Accidents, Battle Casualties, Combat Awards, Combat Awards, Battle List Of Field Commissioned Officers and Unit Citations. page titled Battle Credits Another Normandy, 6 June to 24 July 1944; Rhineland, 15 September 1944 to 21 March 1945; Ardennes - Alsace, 16 December 1944 to 25 January 1945; Central Europe, 22 March to 11 May 1945 and Normandy with Spearhead Device, 6-7 June 1944. My guess is that this book was published by the U.S. Army. If any member knows how this book originated or where it came from or perhaps the title, please send that information to the Chapter Secretary.

## GI BILL UPDATE RAO BULLETIN 15 JUL 2008

The Department of Veterans Affairs recently announced that the Montgomery GI Bill will soon be increased by 20% -- a total increase of nearly \$220 a month increase over last year's rate. The increased full-time student payment rate of \$1,321 multiplied by the 36-month brings the GI Bill total payout to over \$47,500. If you are GI Bill eligible and have benefits remaining, you get this increase no matter when you became eligible or begin using it. 
#### DR. JIM JACKSON
