The current O'Neal Fund was announced in our March 2012 Devils Digest and I started receiving your donations on 30 March. A thank you card was sent to each donor. I had the names and addresses of two people in our Afghanistan deployed 508 PIR, our wounded warrior James Brasher and a Sergeant Major in the Regiment. The Sergeant Major sent me a good shopping list - AA batteries, baby wipes, hand lotion, lip balm, disposable razors, 3-1 shower-shampooshave, sanitizer, tooth brush, paste and holders and water flavoring. Shelf stable snacks were listed. I have added freezer bags and small plastic bags to hold batteries and keep small items dry. My dear neighbor and friend, Almeda Medlin helped me shop for items and fill out the custom forms for the first packages. My dining room - kitchen became a storage and work area.

...We purchased enough items to last for a while. Our first shopping trip cost a lot; Sam's cost \$618.40; Walmart cost \$109.91; PX cost \$105.19; and Hobby Lobby cost \$57.27. The Wallmart store would not accept our 508 Chapter Check, so I paid with my Visa Card and will be reimbursed later. Some outfit called TeleCheck oversees bank checks for Wallmart and approves or gives a thumbs down on bank checks. I went to my banker and he arranged for a Business Check Card to be issued for our Chapter account. It is a Credit or Debit Card. Some places require the pin number to be used, but it has worked well. Our friendly Postal Employees advised me to send packages to Afghanistan using the Priority Flat Rate Boxes, so we filled up six of the largest size which are only 12" X 12" X 6". We sent three packages addressed to the SGM and three to 1SG Brasher on 23 April, they cost \$13.45 each totaling \$80.70. I packed eight more boxes, four for each destination soon thereafter.

Then I received a very touching email that I'll share with you. "Mr. Hamill": "I read the Devils Digest of March, 2012, and want to express my personal gratitude for the honor and courtesy you and the 508th Airborne Chapter recently bestowed on my son, 1SG James Brasher, and his wife, Skye." "As you know, James was wounded in 2007, on his 4th tour of duty to the middle east - by that time, twice to Iraq; twice to Afghanistan." "Several days ago, on May 1st, 2012 (6th tour), he was wounded by what we understand was Taliban recoilless rifle fire while posted to a combat outpost in Afghanistan." "He suffered shrapnel to his upper leg and chest, and has just arrived at Womack Hospital at Ft. Bragg." "James is consistently the model of modesty and master of understatement of his personal discomfort." "So, in pressing him to talk about his wounds, you would think shrapnel through a rib, torn spleen, and nicked and collapsed lung is no big deal." "I think what he really finds painful is leaving his men and work "James has always over there undone." possessed to a high degree the extraordinary physical and mental toughness, drive, and determination that ensures a prognosis for full...

...recovery as excellent." "And through this process, I have the satisfaction of knowing that he will be expertly and lovingly attended to around the clock by Skye – incredibly strong, unflinching, and dedicated to helping him through this, now, and as always." "Naturally, we are all immensely proud of him." "Again, on behalf of myself and my family many thanks to you all for your service and for your show of strong support for my son, James." "All the best to all of you." "Paul Brasher"

I called the Task Force All American Rear Detachment at Fort Bragg and learned that our Warrior 1SG Brasher had been released to the care of his wife Skye. I also asked that our three boxes sent to C Co 1-508 remain there for the troops. I sent the Brasher's a best wishes and get well card on behalf of our Chapter.

I sent four boxes to the SGM on 8 May. The addresses on the remaining four boxes were changed from 1SG Brasher to the SGM and they were mailed on 16 May.

I attended a 506 ABG reunion here in Columbus on 5 May and spoke at length to a gentleman who had sent dozens of packages to troops using the following method: Pack and ship using apple boxes, they are stronger and contain one bushel. Send the bushel boxes via Parcel Post surface transport which means the boxes go to Queens, NY by truck, and then everything is shipped by air from New York to Afghanistan.

I arranged to get apple boxes from Piggly Wiggly Super Market and have also got boxes from the Fort Benning Commissary. The first two bushels were sent on 23 May, weighing 73 Lbs, 9 Oz and cost \$50.81. Unfortunately a senior moment caused me to pay with my personal Visa Card, so I'll reimburse myself. Two bushels were sent on 30 May weighing 71 Lbs. 13 Oz and cost \$50.30. One of the three original boxes sent to 1SG Brasher was returned to my home. A box of 52 disposable razors was scuffed, but the razors looked fine and the other items in that returned box looked good so everything was repacked into a bushel box and sent on 6 June weighing 81 lbs. 10 Oz and cost \$54.63...

... I received an email from Afghanistan on 4 May that slightly edited reads - Ken, I've got all the boxes, and just got the first two bushel boxes yesterday. One of the Sergeant First Classes that works for me has already broken them down and coordinated with the Battalion Liaison Officers at the Brigade, to get them transported to 1SGs all over our area. I ask them to write you if they can, but they are really busy. 1/508 has three First Sergeants wounded. One had a hole in his chest that is healing so he'll stay at Bragg. I believe the other two will stay here after a little recovery and continue to run their Company. 2/508 is doing great things in their area, has had numerous casualties also, and have truly figured some things out. All our units are working hard and making this area a better place and training the Afghan Army & Police to make their country Thanks for all you guys are doing to support us Ken. Send our best regards to all. SGM

I want to thank Ken Glynn and the Orlando Chapter again for sending packages to 508 paratroopers on behalf of the 508 Chapter. If you remember, Ken Glynn was Chairman of the Orlando Chapter and QM of the 508 Chapter during the Regiment's first two tours to Afghanistan. Frank Seif would send money to Ken as donations were received. Ken and his group would buy items and send them to our troopers. Thanks again Ken, hoooaaaah!!!

Buying, packing and sending is a lot of work when things go smoothly. Shop at Sam's, Walmart and PX each week, and other places if items are depleted. For example, I had nine tooth brush holders and needed fifteen more. The PX had none and Wallmart had none. I went to a local CVS Pharmacy and they had ten, so I'll have to find five more or send some extra quart size freezer bags to be used temporarily. The Commissary Manager agreed to provide apple boxes with the condition that I call the produce department one day ahead of time to arrange the transaction. I called produce on a Wednesday, voiced my need for two apple boxes and asked what time do I pick them up tomorrow? Produce said the boxes will be...

waiting here for you all day, so anytime will work. I arrived there the next day after a twelve mile drive and the guy said, what boxes? A few days later I repeated my bad luck story to a young produce guy and he got the Produce Manager. She had read the Commissary Manager's memo. She said you wait here or come back in five minutes and we will unpack some apple boxes for you. They gave me four beautiful apple boxes. Most people want to help our troops serving in Afghanistan and that makes this job a pleasure.

God Bless our Paratroopers of the 4th Brigade Combat Team, 508th Parachute Infantry Regiment, 82nd Airborne Division and all of our Military Members in Afghanistan and throughout the World. Hooooaaaah!!!

I heard from Frank Seif who was interested in the article about MG Wayne C. Smith's division review every payday. "I had been transferred to the 11th Abn Div awaiting discharge." "The NCO Club had a really nice place on Kentucky Lake with rental boats and mobile homes for NCO's." "Smith used to fly up in his little chopper and a friend of mine who ran the boat concession had to host Smith." "He was a real SOB." "I did a number of those payday reviews and I had just been married." "We were broke every payday and needed to get to the store for food but had to do the review." 508 AIRBORNE ATOMIC TESTING Sent by George Kulstad, Svc Co, 1954-56

During April 1953, some members (perhaps a battalion) of the 508th Airborne Regimental Combat Team were ordered to Camp Desert Rock, Nevada to be exposed to radiation from atmospheric nuclear tests. These men could receive a one-time \$75,000 benefit from the U.S. Government under the Radiation Exposure Compensation Act of 1990, or a monthly disability payment of up to \$2,673 from the Department of Veterans Affairs if they contracted any of 21 different cancers traced to radiation exposure, according to the AARP Bulletin, November 2011, page 6. Surviving spouses, dependent children and dependent parents of veterans who died as the result of diseases related to radiation exposure during military service may be eligible for survivors' benefits. The list of eligible cancers include the following: Cancers of the bile ducts, bone, brain, breast, colon, esophagus, gall bladder, liver (primary site, but not if cirrhosis or hepatitis B is indicated), lung (including bronchiolo-alveolar cancer), pancreas, pharynx, ovary, salivary gland, small intestine, stomach, thyroid, urinary tract (kidney/renal, pelvis, urinary bladder, and urethra), leukemia (except chronic lymphocytic leukemia), lymphomas (except Hodakin's disease), and multiple myeloma (cancer of plasma cells). If a veteran who participated in a activity (including radiation-risk Veterans") develops one of these diseases, the VA presumes the disease is related to ionizing radiation exposure during service. veterans do not have to prove a connection between these diseases and their military service to be eligible to receive disability compensation. If you participated in the Camp Desert Rock radiation tests, or if you have a survivor, you or your survivor may want to consider filing a claim with the Department of Veterans Affairs. If you research the cited AARP article online (no computer - visit your local library for help), there are additional links to more information. [Ed Note: AARP became a liberal organization so I dropped my membership.]

MEMORIES OF A PARATROOPER #1 By Edwin C. Carbery

I was assigned to Item Company, 3rd Bn, 508th ARCT 1951-54 at Sand Hill, Fort Benning, Georgia and this is a story of one of my experiences. The Company Clerk came into my barracks and told me to report to First Sergeant Parkinson. The First Sergeant told me that the C.O., Captain Boland, wanted to see me and go into his office. I wondered why the Commander wanted to see me as I headed toward his office. I reported to the Commanding Officer, and he told me to get my gear together and handed me my orders. The next morning I was on my way to Fort Jackson, South Carolina, the home of the 8th Infantry Division and also the Army's Infantry Leadership School. I arrived at Fort Jackson. went to the school, reported in and was assigned to a platoon and met some "straight leg" instructors. They were "bad asses". Soldiers from several outfits were there but only four were airborne, two from the 82nd Airborne, one from the 11th Airborne, and me from the 508 ARCT. All four airborne soldiers were assigned to the same platoon. School started quickly. It was based on Army Field Forces Training Manual 22-7, and we were the school's fifth class. Lieutenant William Thomas was our battalion counselor, and he had several dozen men perform close order drill. The formation sizes were about the size of a rifle company. The Lieutenant had the school instructors give the commands. Then some of us students would give the same commands and march the troops. We were evaluated on our performance. Eventually the Lieutenant picked about ten of us, and we competed with each other until he was satisfied as to his number one choice. He chose me, and suddenly I was the Student Battalion Commander. I spent a lot of time with Lt. Thomas for the next several weeks, and most of it was in the field. We had all kinds of training situations - attacks, offense and defense, day and night; and through it all the instructors were always screaming at us while respecting our rank. I had several "student officers" report to me, and we had to create strategies according to the book. We would be graded on every situation and critiqued while being asked if we...

...could have done a better job. The majority of the field situations were combat situations. Field instruction was usually accomplished using these steps: School cadre instructed us on how a field problem should be executed; students would ask questions and verify field problem instructions; students would go do the problem; instructors and students would critique the problem. Sleep deprivation was constant. I was never so tired in my entire life. The concepts of mission first and team effort were drilled into us. An example of simple problem solving in the field follows: One squad with rifles crossed a river by connecting all the rifle slings together; a strong swimmer carried the sling rope across; held one end of the sling rope and threw the other end to his squad mates; helped the second soldier across and this was repeated until all had crossed the river. One time, Lt. Thomas told me to select four of the best soldiers to escort some debutantes to a dance in Columbia. I picked the three airborne troopers and myself. We danced with some very pretty southern belles, and we finally had a day away from the pup tents, fox holes, rations, mud, and cold showers. Most of all we got away from the constant harassment. The "good life" was soon over, and we were back in the field. Back to attack, counter attack and staying tired. The school helped me to realize that you "get the job done no matter what". I learned what a man can and cannot do under pressure. I learned that a leader takes the lead no matter what the situation is. The four of us airborne soldiers were given permission to go to Fort Bragg to make our pay jumps. We jumped with the 82nd troopers. That sure brought back some memories. We each made four jumps that day, and then we returned to the Our classmates in the school were always asking us Airborne soldiers why we were in such good shape, and we rarely got demerits for our uniforms or our bunk areas. One Trooper would always reply, "join the Airborne and find out". We did stand out among most of the students and even to some of the instructors that we encountered. The highest of standards were maintained with uniforms and polished boots.

Rodger Jacobson sent a message in 2005 about his interesting telephone conversation with LTC Honaker of Knoxville, TN. He was one of the Original 126 Officers and Enlisted men that came from Ft Bragg, NC when they activated the 508 in 1951. He left in December 1951 for Indo-

China. Shortly after that he broke his Pelvis doing a PLF when he landed on his Canteen. He witnessed the Fort Benning jump when Wallace Gunn was killed and was the first on the scene. There was a jeep nearby that had to move so Gunn wouldn't crash into the jeep. He thinks that the Snap on the Static Line wasn't fully closed and bounced off the line as he jumped. He said the Static line snaps were all drilled and safety pins were installed shortly after that fateful jump. LTC Honaker also stated that he knows Bob Murray, but don't remember why.
