#### 82nd ABN DIV ASSN CONVENTION By Jim Strickland, Spt Co 508 ARCT 1953-54

The 82nd Airborne Division Association held its 67th Annual Convention August 14-17, 2013 in Indianapolis, IN. The Convention was sponsored by the Tillman E. Beikes, Indianapolis All Airborne Chapter and they did an exceptional job. It would be remiss not to mention that the Sequester did have an effect which was noted by the lack of attendance of active duty support personnel. The attendance this year was quoted at about 325 which is about half that of last year. The Marriot East Hotel was nice and the facilities were more than adequate for the Convention. The employees were very polite and helpful. The hotel courtyard had a Military Memorial in the center and offered a very comfortable gathering place outside where the cool weather could be enjoyed. Those that were lucky enough had rooms that opened up at that location.

We arrived on Wednesday, August 14, 2013. The processing area was well organized and went very smoothly. It was located next to the Hospitality Room which was open and offered food and drinks of all kinds. The crowd was very small but continued to grow as the week progressed. To me the hospitality room is the "Heart" of the convention. That is where you meet old friends and make new ones. There is always someone interesting to meet and some good stories to exchange. 



#### A PARATROOPERS MEMORIES #2 By Ed Slocum of HQ3-508 ARCT 1955-56

All American member Edward A. Slocum of

Headquarters Company, 3-508 ARCT 1955-56

and Sumter, SC has written his life story. Searching for the Yellow Brook Road is the book title of Ed's life story. Ed would like feedback If we spot an error, pass on the correction so Ed can fix it. Article #2 starts now. Chapter 2, The United States Army-1953 I wanted to join the United States Air Force. Because I was not eighteen years of age, I needed my parent's permission for me to join the military. My mother agreed to sign my enlistment papers. I now realize that this was her way of saving me from a life of hard work and the dead end drudgery in some factory or on the farm. I am sure that I should have gone on to college, however financially it could not be and I did not know how to do it anyway. I went to Omaha, Nebraska which was about 40 miles away to the Army and Air Force recruiting station. I spoke to the Air Force recruiter because I had been a member of the civil air patrol and knew that I liked to fly. The recruiter gave me an enlistment test. I passed it and he then explained to me that he had a waiting list of at least six months, before I could join the Air Force. At age 17, six months was forever and might as well been six years or 60 years. As I was leaving the Air Force recruiter's desk looking sad, the United States Army Recruiting Sergeant who had been listening called me into his office. something to the affect; "Boy, do you like airplanes?" I said, "Yes Sir," And he said, "I'll let you fly". You can become a paratrooper in the United States Army. He went on to explain to me in his best recruiters spiel that I need not worry about the stories I may have heard about getting killed, or about combat missions of U.S. Army paratroopers. He explained to me how great I would look in a dress uniform with spit shined jump boots, a bottle of booze in one hand, and a pretty blonde woman hanging admiringly on my other arm. He also pointed out to me that he was probably wasting his time with me because the paratroopers were an elite unit and that I probably wasn't man enough to belong to it anyway. That was great salesmanship to...

...challenge a 17-year-old boy with the fact that he wasn't really a man and he couldn't measure up anyway. Recruiters have been playing fast and loose with the truth forever, and young recruits like me, hear what they want to hear. I quickly signed up to be a paratrooper. I realized that something was a little different when we got to Fort Omaha, the Induction Center. The medical personnel pulled a guy from Lincoln, Nebraska and me out of the mob for a more stringent physical examination because we were airborne volunteers. One of the things I remember is that the medical personnel required us to do push-ups, pull-ups and certain other agility tests to prove that we were physically fit and able. Of course since I was a refugee escaping from an lowa cornfield, I was physically fit. I passed the physical exam and the test administered to prove my mental abilities. The Recruiting Sergeant said congratulations, you are qualified. I then raised my right hand, took the oath of enlistment August 12, 1953 and became a member of the United States Army.

The recruiters promptly put us on waiting buses that transported us about 175 miles to Fort Riley, Kansas. At Fort Riley, they issued us uniforms and performed more testing and sorted us into groups. After a couple of days they handed me orders for basic training at Fort Jackson South Carolina. They put us on a train for a several day trip to Fort Jackson. I believe that was my first remembered train trip and my first trip to the southern states. It was slow, uncomfortable and the proof that railroad travel in the United States was on its way out.

Fort Jackson, South Carolina: At the Fort Jackson Reception Center, we were processed like cattle on the farm, and quickly turned over to the cadre from Company B, 28th Field Artillery, and 8th Infantry Division. The Sergeant in charge screamed at us that we were jive farmers and other derogatory terms, before taking us to a mess hall where we were fed and then issued sheets and pillowcases and taken to a barracks to spend the night. The next morning, we started taking placement tests. These tests were designed to show our aptitudes and skills. After completing a day of testing, the Cadre Sgt. asks about 20 of us to remain behind for more testing.

I heard from William D. Kelly of the 598 Abn Eng. Company 1952-53 and St Petersburg, FL. His story follows: I enlisted in the Army 26 July 1949 because my draft number was less than a month away. I enlisted for Airborne unassigned. The \$50.00 per month was a huge incentive for a kid making \$1.00 a day. After basic training at Fort Knox, KY, I went to Fort Benning for Jump School Dec 1949 - Jan 1950, then to B Co, 307 Eng. Bn at Fort Bragg. In jump school after the qualifying jumps, the last requirement was to take a glider qualification ride. As I recall, there were 3 gliders used for our orientation ride. The towing aircraft were C-47's. The class lined up Each glider load was in alphabetical order. about a squad size. So, each glider was to make as many flights as needed, until the entire class had their glider orientation ride and were qualified to wear the glider badge. After my stick load landed, we got on a truck and returned to our barracks. We were then free to get our travel gear, assignment orders, sign out and depart on leave in-route to our new duty station. Later I found out the glider containing troops with names starting with an "S" or "T" had crashed, killing all on board. I understand ours was the last class to have a glider qualification ride as part of their jump school training. I have never had the opportunity to verify this account about the crash. I only know that my glider ride was uneventful. Sincerely, William D. Kelly, (Col Ret)


